TERMS FOR USE OF NORTH HIGH SHOALS TOWN PARK

1. Activities before sunrise or after sundown require Council approval.
2. Tobacco products are prohibited.
3. Alcoholic beverages may be allowed under specific circumstances, but are otherwise prohibited without express permission. Please call 706-769-4289 for more information.
4. Profanity and unruly behavior are not permitted.
5. Motorized vehicles are only allowed in the parking area.
6. Decorations, banners, etc. must have approval from Council. Nails, screws, and staples are not permitted.
7. The park is closed periodically for routine maintenance and in the event of inclement weather.
8. Pesticides are occasionally used. Please call 706-769-4289 for more information.
9. Pets must be on a leash at all times, and owners are responsible for cleaning up after their pets.
10. Park users are responsible for placing their trash in the appropriate receptacle(s). Large groups are expected to remove their trash.
11. With the exception of charcoal grills, any fire making requires Council approval.
12. Use of amplified sound equipment requires Council approval.
13. Renters and/or Activity Leaders are expected to possess basic first aid skills.
14. Facilities must be left in a clean and orderly condition. Renters agree to pay for all repairs resulting from any damage, loss, cost of excessive cleanup, etc.
15. Unreserved areas of the park remain open to the public.
16. Renters agree to indemnify, protect, and hold harmless the Town of North High Shoals and its officials from any and all claims, demands, actions, damages, and expenses of any kind.

Park Pavilion - There is a fee of \$10 for town residents and \$25 for non-residents to reserve the park pavilion. Reservations are for 3 hours each.¹

Ball Field - There is a fee of \$5 to reserve the ball field. Reservations are for 3 hours each, and no more than 2 reservations are allowed per week by any group or individual. Multiple weeks may be reserved, with full payment due at the time of initial reservation.

¹ No refunds will be given, but a rain check for future park use (to be redeemed within six months) will be issued. Please call Town Hall to reserve the new date(s).

Pavilion There is a fee of \$10 for town residents and \$25 for non-residents to reserve the park pavilion. Reservations are for 3 hours each.

Ball Field There is a fee of \$5 to reserve the ball field. Reservations are for 3 hours each, and no more than 2 reservations are allowed per week by any single group or individual. Multiple weeks may be reserved, with full payment due at the time of the initial reservation.
